**ENTRIES:** Must be filed with the Race Committee by 1700 hours, on the day of the race.

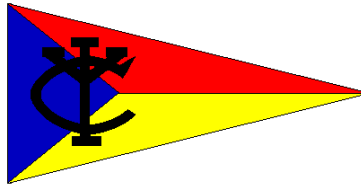
