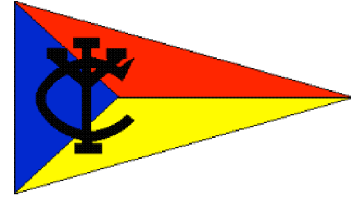


**Island Yacht Club**

**PHRF RATINGS:** If no current PHRF certificate is available, a rating will be assigned which cannot be appealed except by providing a current certificate.

**COURSE:** Courses will be on the Oakland Estuary, and will start at an orange buoy north of the Island Yacht Club. Course sheets and race instructions will be available at [www.iyc.org](http://www.iyc.org) or at IYC prior to the race, or by mail or fax from John New, 510-521-2980.
