**PHRF RATINGS:** A PHRF rating is required for PHRF divisions. The length of the course, for the purpose of determining handicaps, will be listed on the course sheet.

**COURSE:** Courses will be on the Oakland Estuary, and will start at an orange buoy north of the Island Yacht Club. Course sheets and race instructions will be available on the web or at IYC prior to each race. Also by mail from the Rear Commodore.

**DIVISIONS:** A – Spinnaker PHRF 150 & below; B – Spinnaker PHRF 151 & above; C – Santana 22; D – Non-Spinnaker

**ENTRIES:** Must be filed with the Race Committee by 1700 hours, on the day of the race.

**ENTRY FEE:** An entry fee of \$55.00 for both series for USSA members; \$60.00 for non-members.  
\$30.00 for single series for USSA members, \$35.00 for non members.  
\$8.00 per race for USSA members, \$10.00 for non members.

**FIRST START:** Warning gun 1825 hours. Div A 1830, Div B 1835, Div C 1840; Div D 1845.
